

Order after Hearing

1. This Proposal has been filed by applicant school to determine fees for the year 2024 – 25, 2025 – 26 & 2026 – 27.
2. Applicant school is affiliated with GSHSEB Board.
3. School is English Medium School.
4. School is situated at same as above.
5. This Proposal is for Pre-Primary to Std. 8th.
6. This school is registered with 24254100042 U-Dise Number.
7. School has filed this proposal on 16-01-2025 to determine fees for the year 2024 – 25, 2025 – 26 & 2026 – 27. We have gone through the proposal. The school got its permission to function from June – 2024. This committee has scrutinized the documents submitted by the school along with the proposal file and determined the order of provisional fees on dated 26/06/2025. The said order was sent to the school by Speed Post. Being aggrieved by the said order school has filed its objection vide a letter dated 17/07/2025. On 09/10/2025, this committee issued a notice to the school for physical hearing and sought certain documents.
8. On 14/10/2025, Mr. Kuldeep P. Patel, Trustee of the school appeared before the committee and hearing was conducted. During hearing, it is submitted by Mr. Patel that school had spent Rs. 53,87,440/- towards salary. To verify that amount this committee asked to submit salary certificate issued by Bank and therefore the school submitted salary certificate issued by ICICI bank for each Month of 2024-25 of Rs. 42,48,152/-. It is also submitted by Mr. Patel that school had spent Rs. 48,00,000/- towards Rent, which was verified with rent Agreement submitted by School. After perusing the documents submitted by school, it appears that school had projected as loss of Rs. 47,30,670/- in year 2024-25. The total Income of Tuition Fess was Rs. 72,14,040/- in year 2024-25 and the total expenses done by school was Rs. 1,19,44,710/- in the said year.

This committee allow only Rs. 15,00,000/- towards Rent and salary mentioned on Salary certificate, which is Rs. 42,48,152/-, so, the total allowable expenses are Rs. 57,48,152/- and the total Income of Tuition fees is Rs. 72,14,040/-, which is 79.68% of total Fees Receipts of the school and therefore this committee allow 80% of proposed fees and determined the Final Fees as under:


